## INCLUSION THAT LIGHTS THE SPARK OF INNOVATION

OUR PROJECT IN POLAND TO PROMOTE INCLUSIVE ARTS WAS AN EARLY STEP IN A FOUR-YEAR PROGRAMME BRINGING DISABLED ARTISTS TO THE MAINSTREAM OF EUROPE'S CULTURAL SCENE.

We signed a collaboration agreement with Poland's Theatre Institute and the Institute of Music and Dance to improve disabled access to the performing arts. This kicked off with an inclusive theatre workshop in Warsaw, with Jenny Sealey, Artistic Director at Graeae Theatre Company and co-author of London's 2012 Paralympic Games opening ceremony; and Claire Lamont, Head of BA Performance in British Sign Language and English at the Royal Conservatoire of Scotland.

The British Council will now lead a four-year. €4 million programme, bringing together seven European partners to improve disabled access to arts. Using UK best practice, and convening our pan-European network, we are uniquely placed to change attitudes and policy, making the arts more inclusive.

## A GLOBAL CONVERSATION IN THE HEART OF EUROPE

WE SHARED OUR ORGANISATION'S WORK AND EXPERIENCE AROUND WOMEN AND GIRLS' EMPOWERMENT AT THIS YEAR'S EUROPEAN DEVELOPMENT DAYS FORUM.

Held in Brussels, the forum brings together leaders and practitioners in international development, with more than 9,500 people attending over two days. The British Council hosted two panel discussions and joined other debates with partners including the Anna Lindh Foundation and Nzinga Effect. UK organisations such as the Women of the World Festival showcased their work at our stand. Female artist Samya Arif, who is from Pakistan and took part in a British Council project in Nepal, invited people to tell personal stories, which she made into illustrations.

By participating in EDD, we helped to promote the work of UK partner organisations. Our presence sent a message to European partners that the UK is committed to promoting equality of opportunity worldwide.

## FLUENT IN THE UNIVERSAL LANGUAGE OF DANCE

ASSISTED BY THE BRITISH COUNCIL, THE UK'S ROYAL BALLET AND SPAIN'S TEATRO REAL CAME TOGETHER IN A FLASHMOB THAT INVITED DANCERS OF ALL ABILITIES TO TAKE PART.

The British Council connected the two theatres with arts and disability organisations in our network, such as Danza Down, a company of dancers with Down Syndrome, and Fundación Esfera, who work with physically and mentally disabled adults. Their members joined 150 performers and 20 dance associations, and a public audience of over 300.

With a press reach of over 13,000 and coverage in two television programmes, the event promoted the Royal Ballet's *Swan Lake* at Teatro Real and strengthened our partnership with this important Spanish institution. As with all our arts and disability work in the EU, it showed the positive effect an inclusive approach has for all audiences.



This year, we partnered with the Romanian American Foundation the 'English for the Community' project, building capacity among rural English teachers. Thousands of students learn English at our three teaching centres, and we deliver workshops for pupils from hard-to-reach communities. We were official partners of the Sibiu International Theatre Festival, arranging patronage from HRH the Prince of Wales.

We have redoubled our efforts to connect with Romanian partners, enhancing the UK-Romanian bilateral relationship and fostering cultural exchange.

## THE MANY FACES OF A COUNTRY'S CULTURE

IRELAND'S PRESIDENT MICHAEL HIGGINS CAME TO VIEW HIS OWN PORTRAIT ALONGSIDE THOSE OF 80 IRISH CULTURAL FIGURES AT AN EXHIBITION OF WORKS BY BRITISH ARTIST ANTHONY PALLISER.

The British Council partnered with the Office of Public Works and Farmleigh House to organise the 'Face to Face' exhibition. We invited local arts organisations and galleries to the exhibition launch, enabling Palliser to develop business links in Ireland.

Palliser is proud of his Anglo-Belgian heritage, and a spokesperson for art as a unifier across nations. Our support for his exhibition, and the attendance of high-profile figures from government and politics, meant he also represented the UK's commitment to international cooperation. The exhibition curator is keen to pursue more UK-Irish collaborations, and we plan to support the Office of Public Works in their outreach programme beyond Dublin – evidence of the long-term benefits of the project, and of our ability to use the arts for positive UK-Irish relations.

## UP CLOSE AND PERSONAL WITH BRITISH ART

WE MARKED THE 80<sup>TH</sup> ANNIVERSARY OF THE BRITISH COUNCIL IN PORTUGAL IN PARTNERSHIP WITH THE CALOUSTE GULBENKIAN FOUNDATION, BRINGING AN EXHIBITION OF WORKS FROM THE BRITISH COUNCIL COLLECTION.

The British Council collection – which also celebrates its 80<sup>th</sup> anniversary this year – is a catalogue of the best of British art and its role in cultural relations. The selection of works in this 'Post-Pop: Beyond the Commonplace' exhibition showed the importance of British pop art for Portuguese artists when Portugal was under fascist rule.

To tie in with the exhibition, British Council teachers designed and led a series of English workshops based on the artworks, delivered to Portuguese school groups of children aged five to 16. Using one of our richest assets, we were able to build a relationship with a key Portuguese institution, show the positive impact of cultural relations, and engage state schools with UK culture.

## POETRY TO PRESERVE THE NATURAL WORD

THE BRITISH COUNCIL'S BRITISH LITERATURE SEMINARS HAVE RUN FOR OVER 30 YEARS IN GERMANY. WE HELD THE FIRST MUNICH EDITION DURING THIS YEAR'S UK/GERMANY 2018 SEASON.

The seminar, run in partnership with Literaturhaus München and Stiftung Nantesbuch, focussed on resurgent interest in writing about nature in the UK and Germany. Leading British poet Robert MacFarlane chaired the session. On the panel were UK writers Nancy Campbell, Horatio Clare, Sarah Hall, Helen MacDonald and Helen Mort. Online, the seminar had 7,200 live stream views and 2.2 million Twitter hashtag impressions.

UK/Germany 2018 raises the profile of the UK as a culturally rich, internationally engaged country. With this seminar, we showcased British arts and increased opportunities for creative collaboration, with a 'Writers by Nature' scholarship and workshops for young writers from the UK and Germany.

## DO WE BELIEVE IN OUR CULTURAL HERITAGE?

AS PART OF THE UK/GERMANY 2018 SEASON, WE HELD A CONFERENCE FOR 60 PUPILS FROM THE UK AND GERMANY TO DISCUSS THE MEANING OF CULTURE IN THEIR DAILY LIVES.

The weekend involved excursions to explore street art, Berlin's Jewish history, a VR experience of the Berlin Wall and Berlin's former Tempelhof airport. With each visit, students met experts and discussed themes with each other. They then received digital training, before taking over the British Council's social media channels and exploring how digital technology can preserve heritage.

A film made by the students was shown to policy makers at the European Cultural Heritage Summit in Berlin, among them Germany's Commissioner for Culture and the Media. The programme aligned with the 'Next Generation' pillar of the UK/Germany 2018 season, enabling UK and German young people to play an active role in developing their cultural sector.

## **BUILDING THE MUSEUMS OF THE FUTURE**


WORKING WITH LEADERS IN THE GREEK AND UK HERITAGE SECTORS, THE BRITISH COUNCIL'S TRANSFORMING FUTURE MUSEUMS PROGRAMME IS HELPING BOTH COUNTRIES' MUSEUMS ADAPT TO NEW CHALLENGES AND OPPORTUNITIES.

In this phase, we brought 11 Greek museum professionals on a study tour of London, visiting heritage sites and attending the 'MuseumNext' international conference on sector sustainability. The group particularly valued the chance to develop 'vocabulary' of audience engagement, from technology-related terms to promoting inclusion.

Participants have shared their experiences across the Museum Professionals Network, which has grown to over 300 Greek and British experts. More online and offline events are planned as members collaborate to improve public engagement with museums so that future generations can learn from and positively identify with their heritage.

## WHAT DOES THE FUTURE HOLD FOR ENGLISH?

WE COMMISSIONED THE 'FUTURE DEMAND FOR ENGLISH IN EUROPE: 2025 AND BEYOND' REPORT TO EXAMINE DEVELOPMENTS IN THE MARKET FOR ENGLISH LANGUAGE TEACHING (ELT) IN EUROPE.

The report examines English education in France, Greece, Italy, Poland, Portugal, Romania and Spain. It provides political and demographic evidence that English will continue to be an essential life skill for European citizens to 2025 and beyond. This data will empower UK English language providers to further expand the growing European market.

We held an event to launch the report to the English teaching community, attended by representatives from English UK, UK examination and awarding bodies, British and European universities, embassies, and European cultural institutes. We will continue to run an online community and networking sessions to provide the ELT sector with a platform to discuss the findings and develop plans for the future.

## ENGLISH SCHOOL'S IN FOR THE SUMMER!

OUR SUMMER FAIRS IN ROMANIA AND SPAIN CELEBRATED THE ENGLISH LEARNING EXPERIENCE ENJOYED BY MORE THAN 86,000 LEARNERS AT OUR TEACHING CENTRES IN 11 EU COUNTRIES.

Over 1,500 students and parents came to our Bucharest picnic, which marked the 80<sup>th</sup> anniversary of the British Council in Romania. They learned skills, from cricket to coding, and sealed a UK-Romania time capsule to be opened when the British Council turns 100 in 2038. In Spain, 900 visitors attended Summer Family Festivals in Madrid and Barcelona. As well as participating in activities, students took English tests and signed up for our summer camps.

Our teaching centres are vital to our efforts to build positive relations in Europe. Not only do they provide us with a sustainable income, but they also engage learners of all ages with English as a life skill, and present UK culture as friendly, inclusive, and full of opportunities.

## DISCUSSING A EUROPE OF MANY LANGUAGES

OUR 'SHARING LANGUAGES' CONFERENCE ENABLED EDUCATION PROFESSIONALS TO EXPLORE ONE OF THE MOST SIGNIFICANT TRENDS OF THE MOMENT: MULTILINGUAL EDUCATION.

Held on the 20<sup>th</sup> anniversary of our teaching centre in France, we convened French and UK professionals in multilingual education to discuss this growing area of interest. British Council experts spoke on panels alongside leading researchers from France and the UK and members of the French Ministry of Education.

The event reaffirmed our reputation in France and the UK as the authority on English teaching, both in terms of our in-house expertise and our ability to bring together the most influential voices in the sector. As evidence, the Ministry of Education has contacted the British Council about arranging teacher training projects, while plenary speaker Do Coyle is interested in introducing our Science in Schools programme in Scotland.


FameLab International is run by the British Council and Cheltenham Festivals, responding to priorities of all countries involved to improve public engagement with science by training young people in science communication. Over 8,000 people worldwide watched the final live-streamed from London. Germany's finalist Veli Vural Uslu was a runner-up, and Romania's Mihnea-loan Nicolescu won the people's choice award.

During the competition, individual countries hold workshops and share resources drawing on UK expertise. Finalists meet top British scientists and get to know fellow competitors from 27 countries – a taste of the UK's international scientific environment.

## INTERNATIONAL UNIVERSITIES FOR GLOBAL STUDENTS

OUR TRANSNATIONAL EDUCATION (TNE) FORUM, ATTENDED BY HRH THE PRINCE OF WALES, EXAMINED HOW GREEK AND BRITISH UNIVERSITIES MAY COLLABORATE AFTER THE UK LEAVES THE EU.

Greece is Europe's leader in TNE; more than 12,500 students study UK courses based in Greece. Over 100 education leaders joined the forum, including Greek universities and UK partners Universities UK International, exam board QAA, and degree recognition service UK NARIC. The findings of our new research into UK TNE in Greece were a focal point for discussion.

We aim to boost the UK's access to Greece's rich TNE landscape, and made progress at the conference, as Greek directors expressed interest in increasing UK programmes. In addition, we will share our research into TNE in Greece at our 2019 Going Global conference for international education leaders. Using our network, and our insight and expertise, we promote effective internationalisation strategies.

## CHECKING IN TO A WORLD OF INTERNATIONAL SCIENCE

19,000 VISITORS, 120 SCIENTISTS, 110 EVENTS, AND FOUR INSPIRATIONAL DAYS: THE FORMULA FOR BULGARIA'S BIGGEST INTERNATIONAL SCIENCE EVENT, LED BY THE BRITISH COUNCIL.

Now in its eighth year, the Sofia Science Festival promotes public engagement in science, using the example of the UK's rich experience in research and science communication. More than 2,500 pupils take part in the schools' programme. This year, over 100 media broadcasts and publications reported on the festival, and more than 174,000 people were reached on social media.

The UK scientists who participate build connections with peers from 16 countries. Sustained by contributions from 86 partners and with support from the Mayor of Sofia and the British Embassy, the event exemplifies the role that international collaboration plays in UK and European science.

## THE UK SCIENTIST SOLVING HISTORY'S GREAT MYSTERIES

HOW CAN DNA SOLVE A 500-YEAR MYSTERY? PROFESSOR TURI KING EXPLAINED WHEN SHE LECTURED AT SLOVAKIA'S BIGGEST UNIVERSITY AND MOST RENOWNED RESEARCH CENTRE.

Comenius University in Bratislava contacted the British Council for a speaker to celebrate 65 years since the discovery of the DNA double helix by British scientists. Professor King's team at the University of Leicester made international headlines by proving a skeleton found in a car park was that of England's King Richard III. She was the ideal speaker to present the UK as a leader in genetic research.

More than 350 students attended. The university now intends to make the genetics lecture an annual event, with the British Council as a partner of choice. We plan to extend activity beyond the capital to other cities in Slovakia to improve public engagement in science and promote UK expertise.

## A TWO-WAY APPROACH TO CULTURAL RELATIONS

THE BRITISH COUNCIL IS A LEAD PARTNER IN THE APELDOORN CONFERENCE, THE HIGHEST LEVEL BRITISH-DUTCH BILATERAL SUMMIT ON ARTS, EDUCATION, SCIENCE, BUSINESS AND THE MEDIA.

Hosted by the UK's Foreign and Commonwealth Office in London this year, the conference brought together senior leaders to build bilateral relations between the Netherlands and the UK. Delegates included vice chancellors, CEOs of Anglo-Dutch companies, directors of arts institutions, politicians, and senior foreign ministry representatives from both countries. They discussed creative ways of working in areas of joint interest, from arts to security.

As a core partner, the British Council voices those issues that are of highest priority to members of the culture and education sectors in the UK and other European countries. Our aim is to keep arts and education at the forefront of future relations between the UK, the Netherlands and all of Europe.

## **VOTES FOR WOMEN, RIGHTS FOR ALL**

WE INVITED DR HELEN PANKHURST, ACTIVIST AND DESCENDENT OF THE LEADERS OF BRITAIN'S MOVEMENT FOR WOMEN'S SUFFRAGE, TO SPEAK AT FRANCE'S LEADING UNIVERSITY, LA SORBONNE.

Dr Pankhurst's lecture was a highlight in La Sorbonne's summer university programme, which is part of its adult continuing education offer. Registrations filled up ten days before the event. Dr Pankhurst discussed her book, *Deeds not Words*, and her work with international NGOs to push for equality. The lecture was covered by international francophone television channel TV5Monde, along with a number of national and international publications.

The British Council has a reputation for providing the Sorbonne summer university programme with expert speakers on topical areas of British cultural relations – for example, during Shakespeare's 400<sup>th</sup> anniversary year, when we invited the head of the Shakespeare Institute. Dr Pankhurst's lecture lived up to this, and drew attention to the UK's role in promoting equality and diversity internationally, now and into the future.

## PICTURES THAT EXPOSE OUR POLLUTION PROBLEM

THE BRITISH COUNCIL CHAIRED A CROSS-SECTOR DEBATE OF BRITISH AND SWEDISH EXPERTS DURING SWEDEN'S MOST IMPORTANT ANNUAL POLITICAL FESTIVAL, ALMEDALEN WEEK.

Award-winning British photographer Mandy Barker, Chair of the Arts Council England, Sir Nick Serota, Professor John McGeehan from the University of Portsmouth, and Eva Bildberg of Keep Sweden Tidy brought insight from their areas of expertise into solutions to the problem of marine pollution.

More than 40,000 visitors attend Almedalen each year. Held in partnership with the British Embassy and with our Director Sweden Martin Gilbert as moderator, this debate showed the British Council's remote Nordics 'amplification model' in action. Despite having no physical offices, we make connections happen between key individuals and institutions in UK-Nordic relations.
